

RULES AND REGULATIONS

Tournament officials decision will be final on all controversies.

All rules and regulations on Rend Lake and No-Wake areas must be obeyed.

Any unsportsmanlike conduct will result in immediate disqualification.

No alcoholic beverages will be permitted in the boat during the tournament.

All boats will meet the State of Illinois, Coast guard regulations and MPH limits.

Boats must have Kill Switches and adequate live wells. Life preservers must be on when outboard motor is running.

Team members must fish together. No trolling. Artificial baits only.

Only large mouth bass will be weighted. Bass must be 14 inches or longer. A limit of 5 bass per team. All bass will be measured on a flat bump board. No courtesy bump. One lb. penalty for any short fish thereby resulting in loss of fish. One lbs. penalty on dead fish. Limit one per team. LATE CHECK-IN WILL RESULT IN DISQUALIFICATION.

No boat will fish within 50 yards of an anchored boat.

Protests must be filled in writing with in 15 minutes of weigh in and signed by person making the protest.

No bass will be weighed before 2:30 pm.

All fishermen must be in the weigh-in line with in 15 minutes after last flight check in time.
